I, **Juan Manuel Rueda**, do solemnly **affirm** that I will faithfully execute the **Office for Clerk for the Court** for The United States of America, and will to the best of my Ability, preserve the Articles of Confederation as amended, protect the honor of The United States of America and defend the former Articles of Confederation, 1781, and the present Articles of Confederation, as amended for The United States of America against all foreign powers; and

I, **Juan Manuel Rueda**, having taken an oath or affirmation of **Office for Clerk for the Court** for The United States of America on the **327th day, in the year of Yahweh 6017**, do hereby accept and acknowledge the said position, duties and responsibilities as the **Clerk for the Court** for The United States of America, until the next election which will be in the year of Yahweh, 6019, with a probationary period of 90 days from the day of appointment. After the 90 days, the appointment shall go before the assembly convened to either terminate the appointment, or extend the appointment depending upon the positive and negative performance of the **Clerk for the Court**; and

CERTIFICATION OF ADMINISTERING OATH OR AFFIRMATION


